**INSTRUCTIONS ON DRAFTING PAPER**

*The paper will be in Romanian and in an international language on no more than 10 pages in A4 format with margins left / right 20 mm, margins below / above 20 mm (except first page containing title, authors, abstract and keywords) in MS Word format, Times New Roman font, font size 12, line spacing at 1.*

*Title will be centered, preceded by three blank rows from the upper edge of the page, in capital letters, Times New Roman font, font size 14, bold.*

*Name and surname will be centered, at 2 lines under the paper title, in capital letters, Times New Roman font, font size 12, bold. If there is more than one author use a semicolon to separate each different author.*

*Authors' workplace(s) must be centered on the line immediately following that name of the author(s) work, TimesNew Roman font, font size 12, bold.*

*Abstract (in English) must be written at a distance of twolines from the row that contains the workplaces of authors, Times New Roman font, font size 12, on no more than 10lines.*

*The keywords must be written under the abstract, after two blank rows, Times New Roman font, font size 12.*

*The paper will be written under the keywords, after 2 blank lines, Times New Roman font, font size 12.*

*The chapter titles will be written in capital letters, bold, left aligned, Times New Roman font, font size 12 and will benumbered with Arabic numerals.*

*The paragraphs that make up the paper will start at a distance of 15 mm from the left edge of the page, aligned left/right (justify). Between the title chapters and the first paragraph of the chapter there will be a blank line.*

*Subsections will be written with Times New Roman font, size 12, bold and start at a distance of 15 mm from the leftedge of the page.*

*Sub-subsections will be written with Times New Roman font, size 12 italic, centered.*

*Figures will be placed within the text and numbered.*

*Formulae and equations are to be numbered on the rightside of the page.*

*The tables will be numbered in the top right side and thetitle placed in the top left side.*

*References will be placed at the end of the paper after twoblank lines.*
